Proposed Draft amendment 4......2019 to AIS-145 Additional Safety features for Category M & N Vehicles

1. Page 2/26, Clause 5.6,

Substitute following text for existing text:

Vehicle Reverse Parking Alert shall meet requirements of Annexure 7 for vehicles other than M1 category.

Wherever rear end construction of vehicle is such that it is not possible to comply with the requirements of Annexure 7, it shall be permissible for vehicles of category other than M1 to comply with the requirements of Annexure 6 as an alternative after justification to the test agency. Provided that in case of tippers a reverse buzzer (audible warning system when vehicle is driven in reverse) may be provided as an alternative.

Tractors including Puller Tractors of N category shall be exempted from the requirements of both Annexures 6 & 7.

(**Justification:** Considering similar nature of operation of tippers and construction equipment vehicles, the provision under CMV rule 105(8-A), for reverse buzzer is extended to tippers as well).
